The selected candidates for individual Universities for the **Post-graduate Programme** are required to send the enclosed **Letter of Acceptance** duly signed to **CLAT Office** along with a demand draft for **Rs. 10,000/- (Rs. 5,000/- in case of SC / ST)** drawn in favour of **'Convenor, CLAT-2009 (NALSAR)'** payable at Hyderabad on or before **29th June, 2009**. The Candidates are also required to report personally at the allotted University on **4th July, 2009** for completion of the admission formalities by remitting the first year fee excluding the payment of **Rs. 10,000/- or Rs. 5,000/-**, as the case may be, and by submitting original documents as per the requirement of the concerned University.

The selected candidates are further required to contact allotted University for details with regard to the amount of fee to be paid along with the Original Documents to be submitted at the time of admission.

If any candidate fails to send the Letter of Acceptance to CLAT Office at NALSAR and fails to complete the admission formalities at the allotted University on 4th July, 2009, he / she will not be eligible for admission at any of the eight National Law Universities and the amount of Rs. 10,000/- or Rs. 5,000/- paid by him / her to CLAT Office shall stand forfeited.

The first allotment to all the Universities is purely based on 'merit-cum-preference' as indicated by the candidates in the Application Form. The confirmation of the allotment after resolving the tie, if any, or adjustment of candidates against the available vacant seat at their higher preference, will be notified on the website by **30th June, 2009**.
